Holiday Gift Exchange Rules

- Bring a wrapped gift--a plant or an orchid related item that you yourself would like to receive (suggested limit \$25)
- 2. Pick up a ticket (hold onto it!) and place your gift on the table in the middle of the room. Take a look at what people brought without undoing the wrapping.
- 3. Each person whose ticket number is called will select a gift, also without undoing the wrapping (guessing is part of the game!), then show the gift to the audience reading the label, describe the item, etc. The next number will be called after we've all had a chance to admire your gift.
- 4. Put the gift you chose on your table and keep it there where everyone can see. No putting it down on the floor or otherwise hiding it.
- 5. The next person whose turn it is can either "steal" yours or any other available gift. If yours is stolen, it'll be your turn next to pick.
- 6. Each gift may be stolen up to twice. After the second time, the gift is considered "dead" and cannot be taken away from that person.

The President's Letter

Holiday greeting to my orchid friends!

I hope you were able to join us for last month's meeting, either in person or virtually. KellyMcCracken's presentation on growing orchids under artificial light was chock full of great information. There was a **lot** of material presented, so if you want to review the content of the talk (and more), Kelly had a 5-part series of articles in *Orchids*, the magazine of the American Orchid Society (AOS). The series started in the July 2021 issue and concluded in the November issue. If you are an AOS member, you have access to those articles either in the print editions or via the online archive.

This month, in lieu of our normal meeting, *we're holding our annual Holiday Potluck Dinner*. Note that the party will be held on the *first* Thursday of the month, December 7, instead of our normal second Thursday due to venue availability issues. Unfortunately, I'll miss this year's gathering, but I'll be with you in spirit. Have fun! Remember that you must have paid your 2024 dues before the event in order to be eligible for a special plant drawing for early-paying members.

December is a somewhat slow time of year for my orchids. My *Leomesezia* Lava Burst 'Puanani' is **still** in bloom. (I think this is the 4th month I've written this!) My *Cymbidium* Amaretto, a reliable annual bloomer, has one spike that has opened and three more almost ready to bloom. My *Neostylis* Lou Sneary 'Bluebird' is in spike and almost ready to open. I was also excited to discover that my No-ID reed-stem *Epidendrum* set a seed pod this year. That's the first time one of my orchids has done this. I'm not sure if this was self-pollinated or was cross-pollinated by my one other *Epidendrum* that was in bloom at the same time. I'm going to send the pod off for propagation. Wish me luck!

Proposed amendment to the DVOS Constitution

We are a small Society, and recruiting volunteers for leadership positions remains difficult. Our Constitution currently defines the "Officers" of the Society as the President, Vice President, Secretary, Treasurer, Immediate past President and at least five Directors at Large. No officer, except the Treasurer, can serve for more than two consecutive terms in the same office (or until his or her successors are elected). The Board is proposing to modify (amend) Article 4 of our Constitution to restrict the 2-year term limit to just the President, Vice President, and Secretary, as well as modify the terminology of the Board positions, making the elected "Officers" just four "named" positions (President, Vice President, Treasurer, and Secretary).

The proposed amendments will be presented at the November meeting and voted on at the December Holiday Party. A two-thirds majority of the members in attendance must vote in approval of the amendment for it to be approved.

Proposed changes:

(Strike-outs in red, new words in green)

Article 4. Officers and Board of Directors

<u>Section 1.</u> The elected officers of this Society shall be a President, Vice President, Secretary, and Treasurer, <u>Immediate past President and at least five Directors at Large</u>.

<u>Section 2.</u> The Board of Directors shall consist of the elected officers, and the Immediate past President, and at least five elected Directors at Large.

<u>Section 3.</u> No officer, with the exception of the Treasurer, shall be eligible for more than two consecutive terms in the same office or until his or her successors are elected.

<u>Section 4.</u> The officers Board of Directors shall assume the duties of their respective offices at the January meeting following their installation at the December meeting.
